

# Alibi App Launch Giveaway Terms & Conditions

## Promoter

The promoter is Alibi Brewing Co., located at Tantalus Estate, 70 Onetangi Road, Waiheke Island, Auckland, New Zealand.

Promotion period

The Alibi App Launch Giveaway begins on Friday 12 June 2026 and closes at 11:59pm on Thursday 16 July 2026.

The winner will be announced on Friday 17 July 2026.

## Eligibility

Entry is open to those aged 18 years and over.

Employees of Alibi Brewing Co., Tantalus Estate, associated agencies, suppliers, and their immediate families are not eligible to enter.
